- 01/06 Barnet, Inspector conducted a portable weigh on a commercial motor vehicle and discovered the vehicle was 9,600 lbs. over there permitted weight of 99,000 lbs. The carrier was issued a ticket.
- 01/06 Inspector conducted a TACT stop on I89 in Berlin, the operator was stopped for traveling at 94MPH and operating unsafely around commercial motor vehicles.

Passenger Vehicles: Nothing to report

SOUTH SECTOR:

Details:

- 1/7, 1/7, Vernon SB; 6 inspectors screened 233 vehicles and completed 22 inspections resulting in 4 driver and 9 vehicle violations; one vehicle was placed out of service.
- 1/8, Rockingham, High Priority Detail; 2 Inspectors completed 9 inspections resulting in 5 vehicle violations; one vehicle was placed out of service.
- 1/9, Randolph; 3 inspectors screened 213 vehicles and completed 11 inspections resulting in 2 driver and 5 vehicle violations; one vehicle was placed out of service. Additionally, one vehicle was force permitted for not having an oversized permit.

Crashes:

Notables:

- 1/7, Vernon, Cpl. found two leaking inner wheel seals and an underinflated tire on an interstate combination; the tire measured 40 psi on a 110-psi max inflation which was less than the required 50%. The trailer was placed out of service for the flat tire and inflated roadside by the driver.
- 1/8, Rockingham, Cpl. placed a trailer out of service for a flat tire; measured at 20 psi with a max inflation of 120 psi. The tire contained less than the required 50% inflation.

• 1/7, Inspector stopped an interstate truck and trailer for a fictious trailer plate. The truck was placed out of service for an inoperable parking brake. The trailer was placed out of service for inoperable trailer brakes. The driver had no medical card.



• 1/7--Cpl stopped the driver of a box truck for speeding on Route 22a in Orwell. The truck was placed out of service for no operable parking brake and for the axle 1 tire in contact with another vehicle component.



• 1/7--Cpl stopped the driver of a tractor trailer for speeding on Route 22a in Orwell. The carrier was found to be under a federal out of service order. The driver left NJ for VT early in the morning and was headed back to NJ. The truck tractor had no heat, and the driver said the carrier told him to make this run anyway. The inside temperature of the cab was taken and was found to

be 25 degrees F. The outside windchill factor was 7 degrees F. The driver didn't start a paper log for the day reporting that all the pens in the cab had frozen. The driver displayed multiple signs of being more than just cold and he was brought to the Fair Haven Welcome Center to warm up.



• 1/9, Inspector stopped a truck that failed to stop at the Fair Haven Scale House for inspection. The driver had a corrective lenses restriction yet was not wearing glasses nor had any available in the vehicle. The driver was placed out of service.



• 1/9, Inspector stopped a truck that failed to stop at the Fair Haven Scale House for inspection. The truck was placed out of service by NYSP two hours prior, yet the driver failed to properly fix a leaking brake hose. The truck was placed out of service and escorted to a repair facility in Castleton.



- 1/9, Inspector stopped a log truck on Route 7 in Rutland. The trailer was placed out of service for no warning flag on a log that extended more than 48" past the rear bumper.
